

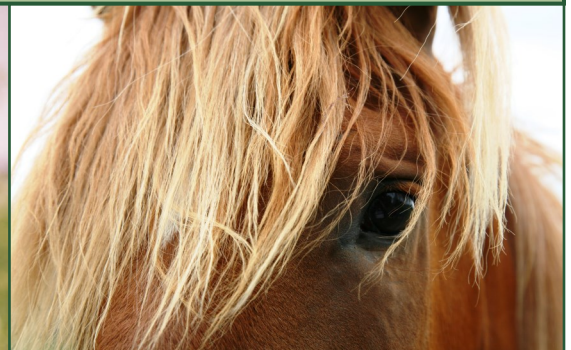

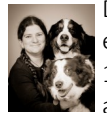
### Robert L. Bergman, DVM, MS, DACVIM (Neurology) - Bridger Vet Specialists - Bozeman, MT



Dr. Robert (Bob) Bergman will be visiting Montana periodically to see neurology cases and perform neurosurgery at BVS. He graduated from the University of Georgia and completed advanced training in neurology and neurosurgery at Virginia-Maryland College of Veterinary Medicine. He completed a Master's Degree at Virginia Tech focusing on neuroscience and cerebrospinal fluid. He is board-certified by the American College of Veterinary Internal Medicine as a small animal neurologist.

### Lisa Parshley, DVM, PhD, DACVIM - Olympia Vet. Cancer Center - Olympia, WA



Dr Parshley currently works at and co-owns the Olympia Veterinary Cancer Center. She earned a Ph.D in biochemistry, in 1994, from Oregon Health Sciences University. After finishing a University of Washington post-doctoral fellowship she worked for the Immunex Corporation. She was given the opportunity to work at an animal emergency hospital and developed a real love of veterinary medicine. In 2003 she received a DVM from Colorado State Univ. and a year later completed a small animal internship at Cornell University. After finishing a medical oncology residency at Michigan State University she became a diplomat of the American College of Veterinary Internal Medicine (oncology). Dr. Parshley has lots of experience in biomedical research, emergency medicine (her other love), critical care, and palliative medicine.

Dr. Jayce Lineberger was born at the Air Force Academy in Colorado Springs. He grew up in Oklahoma and graduated from Oklahoma State University for Veterinary Health Sciences in 1993. He practiced for five years in a rural mixed-animal practice in Oklahoma before pursuing advanced training in small animal surgery. Dr. Lineberger completed a rotating small animal internship in Kansas City and a surgical internship in Maryland before returning to Kansas City to complete a small animal surgery residency. He became a Diplomate of the American College of Veterinary Surgeons in 2009. He currently performs a wide variety of orthopedic, and soft tissue surgeries with his mobile surgery practice serving veterinary clinics in northern Colorado & across Wyoming. He is a certified PennHIP provider.

## LARGE ANIMAL SPEAKERS

### Geof Smith, DVM, PhD, Dipl. ACVIM - Zoetis - Raleigh, NC



Dr. Geof Smith received a BS in animal and dairy science from Clemson University in 1994 followed by a DVM from the University of Illinois in 1998. Following graduation, Geof remained at the University of Illinois for another 4 years while he completed an internship and residency in ruminant internal medicine along with a PhD in physiology. Dr. Smith joined the faculty at North Carolina State University in 2002 and was a Professor of Ruminant medicine. In May of 2021, he joined Zoetis as a dairy technical services veterinarian. He is a Diplomate of the American College of Veterinary Internal Medicine (ACVIM) and his primary clinical and research interests revolve around clinical medicine of cattle with a specific focus on calf health. He has published over 100 peer-reviewed manuscripts and has edited 2 books on calf health and fluid therapy.

- **Fluid therapy for calf diarrhea** – This talk will review the pathophysiologic changes that occur with calf diarrhea and how they can be addressed from a treatment standpoint. We will talk about oral electrolyte therapy and how to choose the ideal product for use in practice as well as how to effectively deliver intravenous fluids on farm.

### Ted P. Vlahos DVM, MS, DABVP (Equine) - Yellowstone Equine Hospital - Cody, WY



Dr. Ted Vlahos is a 1988 graduate of the Ohio State University and is the owner of Yellowstone Equine Hospital, PC in Cody, WY. Dr. Vlahos has served two terms as Equine Regent on the ABVP Council of Regents, was founder and Chair of the ABVP Ethics Committee, as well as a member of the AAEP Professional Conduct and Ethics Committee. Dr. Vlahos is Chief Medical Officer-Orthopedics of BrightHorse Equine Performance in San Marcos, CA. Dr Vlahos is widely published and is regarded as a pioneer in the development of amputation and prosthesis techniques in the horse. Dr. Vlahos lives in Cody, WY with his wife Cathy, and their very spoiled Labrador Retrievers.

- **Current Treatment of Equine Tendinopathy and Desmopathy.** The lecture will review pathogenesis and treatment of equine tendon and ligament disorders and introduce innovative procedures for the general practitioner.

- **Emerging Technologies in Equine Practice.** The lecture will introduce new and emerging technologies designed to enhance workflow and safety for the equine practitioner and support staff with a focus on application in the general practice setting.

### Scott Hancock, DVM - Boehringer-Ingelheim - Santee Nacoochee, GA



Dr. Scott Hancock received his DVM degree from Auburn University. He began practicing in rural Amish country in Ohio then moved south near Atlanta, GA where he developed a full service equine surgical/referral and ambulatory practice. Dr. Hancock was recruited by the CDC to serve as attending veterinarian and project officer for a hyperimmunization project to create antibodies against biological warfare threats, which resulted in the first FDA licensed product made from horse plasma for treating people against a deadly neurotoxin. After 23 years of active equine veterinary practice and completion of the CDC mission, Scott decided

to pursue science-based medicine and is enjoying his new career at BI working with equine veterinarians and horse owners.

- **PPID and EMS** - Discuss practical updates on testing, lab samples, TRH stim product use and availability.
- **EGUS** - Equine ulcers can not be overlooked in our equine caseload. A glass model was developed to better explain what actually occurs with treatment and how common sense preventative measures can decrease costly reoccurrence.
- **Preconditioning** - We have developed a visual viral model to simplify how vaccines work. These models may engage interaction for why Veterinarians are the best resource for the concept of preconditioning for optimizing protection.

### Matt Martineau, RPh - Executive Director, WY State Board of Pharmacy



Matt graduated from the University of Wyoming School of Pharmacy and is a Wyoming native. He began his pharmacy career as a clinical pharmacist for a critical access hospital in rural Nebraska before returning to Wyoming. He has worked in numerous pharmacies across Wyoming communities, including Cheyenne, Casper, Gillette, Sheridan, and Jackson. He joined the Wyoming State Board of Pharmacy as an inspector/compliance officer in 2017. He has served as the executive director of the Board since 2019.

During that time, he has worked numerous regulatory, civil, and criminal cases. DI Davis is currently assigned to the Diversion Staff whose primary focus is enforcing Code of Federal Regulations requirements at the regulatory level.
